## ORDER:

Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India has communicated State Reform Action Plan(SRAP)-2020 with 301 reforms and has mandated that the reforms are completed by 30.11.2020. SRAP-2020 mandated under Ease of Doing Business(EoDB), Procurement undertaken by Industries department has been added as a separate area in the Action Plan. The following are the 6 reforms pertaining to procurement:

Area 15: Procurement (Department of Industries)

1.	296	Ensure information on fees, procedure and a comprehensive list of all documents that need to be provided are available on the web site
2.	297	Define clear timelines mandated through the Public Service Delivery Guarantee Act (or equivalent) legislation for approval at each stage during pre, during and post procurement process
3.	298 ;	Design and implement an online single window system and mandate the following features without the requirement of physical visit to the department: i. Submission of application ii. Payment of application fee iii. Track status of application iv. Download the final signed certificate v. Third party verification
4.	299	Publish an online dashboard updated regularly (weekly/fortnightly/monthly) for procurement. The dashboard should clearly highlight the procurement done and the time taken (Mean/Median)
5.	300	Develop an independent Grievance Redressal Mechanism for handling cases related to complaints
6.	301	Ensure all the records and documents covering entire procurement process should be kept in an electronic format

2. The Industries Department is currently, procuring various goods and services from the private sector through various agencies. There is a need for creating a unified/single agency for quick and easy procurement.

Further, Telangana State Trade Promotion Corporation Limited (TSTPC) has been incorporated on 27-09-2014 after the State re-organization on the line of APTPC to play a catalytic role in the promotion of trade and Industry. As per point C(1) of Memorandum of Association of Telangana State Trade Promotion Corporation Limited, "Other objects for which the company is incorporated are":

To undertake the processing, conversion, fabrication, **trading**, manufacture and production of any category of goods, commodities, merchandise and articles as required by the government of Telangana purely for public purpose and as a temporary measure.

In the reference 2<sup>nd</sup> read above, it has been proposed to nominate Telangana State Trade Promotion Corporation (TSTPC) as the procuring Agency for Public Procurement undertaken by Industries Department to comply with the reforms perfaining to procurement under SRAP-2020. Also, the above reform features are to be implemented through an online system.

5. Government after careful examination hereby nominates Telangana State Trade Promotion Corporation (TSTPC) as the procuring Agency for Public Procurement undertaken by Industries Department for implementation of the reforms through an online system.
